

## **SUMMARY ANNUAL REPORT**

### **For Prisma Health Welfare Benefits Plan**

This is a summary of the annual report of the Prisma Health Welfare Benefits Plan, EIN 82-2595551, Plan No. 501, for period 01/01/2023 through 12/31/2023. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Prisma Health has committed itself to pay certain self-insured Medical, Dental, Employee Assistance Program, and Severance claims incurred under the terms of the plan.

### **Insurance Information**

The plan has contracts with Vision Service Plan, MetLife Legal Plans, Medical Air Services Association, Inc., Combined Insurance, Provident Life and Accident Insurance Company, Standard Insurance Company, and Unum Insurance Company to pay Vision, Life Insurance, Short-term Disability, Long-term Disability, Accidental Death and Dismemberment, Legal, Critical Illness, Hospital, Accident, and Emergency Transport claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2023 were \$34,586,212.

Because they are so called "experience-rated" contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ending 12/31/2023, the premiums paid under such "experience-rated" contracts were \$22,785,542 and the total of all benefit claims paid under these contracts during the plan year was \$21,753,752.
